

## Family Orbit®: Parental Consent Form

If you have a child under the age of 13, you need to send this parental consent form to us before you can begin using the Family Orbit app or service to monitor, track and block their activities.

The parent or legal guardian of the child under 13 years of age must fill and sign this form and send it to us, before they can add a child under 13 to their Family Account. Once you have granted consent for the child to use the Service, Family Orbit will collect information such as name, email address, cell phone number, device ID, location data, text messages, call history, photos, website visited, chat messages, applications installed list, profile photo, and other identifying data. Family Orbit will disclose this information to the parents and other members of the Family Account that have permission to access this information. The access to the Family Account is invite-only. The child will be able to send messages, photos, Check-In, Pick up or Panic alerts with their current location to your Family Account. Family Orbit will not share this information with third party service providers or partners for advertisement purposes. However some information may be accessible to the programmers or support agents. Please refer to our privacy policy for further information. Child account is not able to make the In-App purchase in Family Orbit.

Parental Consent is required for the collection, use or disclosure of information from children under the age of 13. Family Orbit will not collect any information without the consent.
